THE SHELTER TOOK IN 552 ANIMALS DURING THE YEAR AND HAD 382 ANIMALS ADOPTED, 129 ANIMALS WERE RETURNED TO THEIR OWNERS, 36 ANIMALS WERE TRANSFERRED IN FROM OR TO OTHER SHELTERS, 4 ANIMALS WERE EUTHANIZED FOR HEALTH REASONS AND 1 ANIMAL WAS EUTHANIZED FOR BEHAVIOR REASONS. IN 2015 MCPAWS, INC.'S SPAY AND NEUTER PROGRAM WAS SUCCESSFUL IN SPAYING AND NEUTERING ALL ADOPTED ANIMALS THAT WERE NOT ALREADY ALTERED. IN ADDITION MCPAWS, INC. 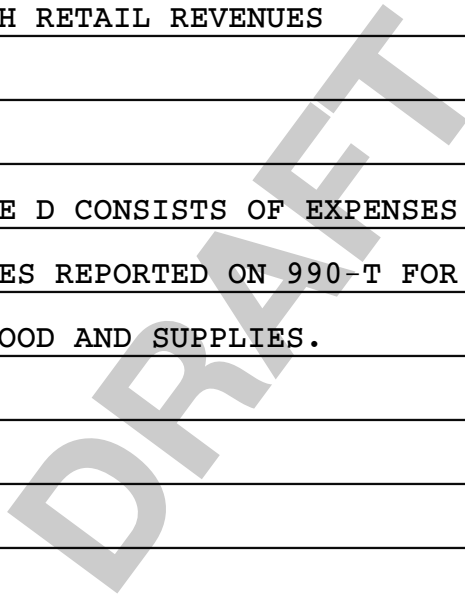

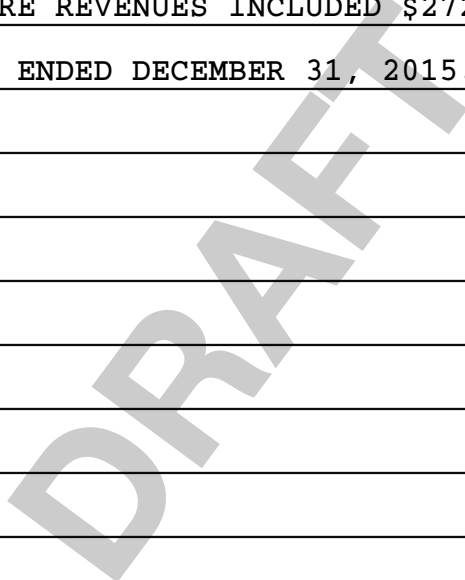
