TOTAL ANIMAL INTAKES FOR THE YEAR WAS 598. 399 DOGS AND CATS WERE ADOPTED INTO LOVING HOMES, 135 LOST ANIMALS WERE RETURNED TO THEIR OWNERS, 47 WERE TRANSFERRED TO PARTNER ORGANIZATIONS, 17 ANIMALS DIED IN OUR CARE, AND THREE WERE EUTHANIZED. ALL SHELTER ANIMALS ARE SPAYED/NEUTERED, VACCINATED, AND MICROCHIPPED BEFORE BEING MADE AVAILABLE FOR ADOPTION. MCPAWS PROVIDED SPAY/NEUTER SURGERIES FOR AN ADDITIONAL 155 DOGS AND CATS IN 2018 AS PART OF OUR COMMUNITY OUTREACH PROGRAM.
