ALL SHELTER ANIMALS ARE SPAYED/NEUTERED, VACCINATED, AND MICROCHIPPED BEFORE BEING MADE AVAILABLE FOR ADOPTION. MCPAWS PROVIDED SPAY/NEUTER SURGERIES FOR AN ADDITIONAL 155 DOGS AND CATS IN 2019 AS PART OF OUR COMMUNITY OUTREACH PROGRAM.
