THIS PROGRAM ENSURES THAT PET OWNERS IN OUR COMMUNITY HAVE ACCESS TO HIGH QUALITY VETERINARY CARE FOR THEIR PETS AND ALSO PROVIDES SUBSIDIZED VETERINARY CARE TO THE PUBLIC ON AN INCOME BASED DISCOUNT PROGRAM. MCPAWS VET ALSO PROVIDES EMERGENCY AND/OR SPECIALIZED CARE TO SHELTER ANIMALS, ON AN AS NEEDED BASIS, WHEN ANIMALS NEED VET CARE BEYOND WHAT CAN BE PROVIDED AT OUR SHELTER LOCATION.

ALL SHELTER ANIMALS ARE SPAYED/NEUTERED, VACCINATED, AND MICROCHIPPED BEFORE BEING MADE AVAILABLE FOR ADOPTION.
